Annual General Meeting and Constitution Changes

All Members (Individual and Corporate) are usually invited to attend the Bereavement Care Annual General Meeting. However, in these times of "social distancing" it may not be possible to hold a 'physical' meeting (at least for more than a representative group of Members). The current Constitution didn't allow for these circumstances, but any changes to the Constitution have to be agreed IN WRITING by ALL Members (if a 'physical' meeting is not possible). Thus, ballot forms to amend the Constitution have been sent to all Members with a return date of 21st September. The length of tenure for Trustees becoming a three-year term, which has been discussed previously, forms part of these amendments. This will help to maintain a degree of continuity on the Trustees Board.

Forthcoming Online (Zoom) Training

Due to current guidelines on "social distancing", it is not possible to run our usual training courses. We are trialling a new online course "**Introduction to Bereavement Support**" Webinar on Zoom, on two **Saturdays** this month **12th & 26th September 2020** from 10.00am – 12.00pm (both dates required) for new trainees and volunteers. The course covers the absolute "basics" and is **not** a replacement for the Initial Bereavement Training Course, which trainees will be encouraged to attend when it is safe to run.
